**NOTICE REGARDING OBJECTIONS TO RECEIVER'S OTHER CLAIMS REPORT**

To all parties holding Other Claims<sup>1</sup> (the “***Other Claimants***”) in Pride of Austin High Yield Fund I, LLC (“***POA***”):

**YOU ARE RECEIVING THIS NOTICE BECAUSE YOU MAY HAVE OR HAVE ASSERTED A CLAIM IN THE RECEIVERSHIP ESTATE. THEREFORE, YOU SHOULD READ THIS NOTICE CAREFULLY AND DISCUSS IT WITH YOUR ATTORNEY. IF YOU DO NOT HAVE AN ATTORNEY, YOU MAY WISH TO CONSULT ONE.**

Please take notice that on April 30, 2024 (the “***Appointment Date***”), the 201<sup>st</sup> Judicial District Court of Travis County, Texas, (the “***Receivership Court***”) entered an order (the “***Receivership Order***”)<sup>2</sup> appointing Gregory S. Milligan of HMP Advisory Holdings, LLC d/b/a Harney Partners (the “***Receiver***”) as receiver over all assets owned by or in the possession or control of POA (such assets, the “***Receivership Estate***”). Having exclusive jurisdiction over the Receivership Estate, the Court entered its *Order Granting Receiver's Motion to Approve (I) Proposed Claims Verification Process; and (II) Claims Bar Date* dated June 17, 2024, establishing a process and procedure for the determination and allowance of all claims against the Receivership Estate (the “***Claims Order***”).

The Claims Order also approved the form notices to Other Claimants (the “***Other Claims Notice***”) and established (a) deadlines for Other Claimants to submit (i) General Claims arising on or before the Appointment Date and (ii) Administrative Claims arising after the Appointment Date and (b) procedures for the Receiver to make a recommendation as to the allowable amount and priority of each Other Claim by filing an Other Claims Report.

<sup>1</sup> “Other Claims” are General Claims and/or Administrative Claims, as defined in the Claims Order. Any capitalized terms not defined herein shall have the meaning ascribed to them in the Claims Order.

<sup>2</sup> The Receivership Order was amended on May 6, 2024.

On January 20, 2025, the Receiver filed the Other Claims Report, and it was mailed and/or emailed to each Other Claimant.

If your claim was listed in the Other Claims Report and you disagree with the portion of the Other Claims report related only to your claim, you may file a written objection or response with the Court to the Other Claims Report or before **February 3, 2025**. The Receiver will attempt to resolve any objections or responses to the Other Claims Report by agreement; however, if an objection or response cannot be resolved by the Receiver and the Other Claimant, it will be decided by the Court, with such determination being the final determination as to such Claim.

If no objection to the Other Claims Report is timely filed with the Court, it shall be the final, binding determination on each Other Claim.

The Other Claims Report may be amended from time to time as determined by the Receiver (an ***"Amended Other Claims Report"***). If the Receiver sends an Other Claimant an Amended Other Claims Report, then the objection process described above will be applicable with any deadlines to object running from the date that the Amended Other Claims Report is mailed or emailed.
